

Who we are.

We are part of Auto Sleepers Group Ltd (ASG) and trade under the names of Marquis Motorhomes, Marquis Caravans and Marquis Leisure.

Whose products do we offer?

We only offer products from a limited number of insurers for **Guaranteed Asset Protection (GAP)**. Ask us for a list of insurers we offer products from.

Auto-Sleepers Group Ltd is appointed to act as the agent of the insurer(s) and not as your agent. When offering or recommending the above product(s) and where we collect any premium or handle premium refunds, we do so as the agent of the insurer.

We act as a credit broker, not a lender, for introduction to a limited number of finance providers only for: Hire Purchase and Personal Contract Purchase (PCP).

Our panel of lenders, who may be able to finance your purchase includes Black Horse Finance.

We will only introduce you to a lender with your prior authority. We do not offer independent financial advice.

You are under no obligation to make use of any financial product arranged by Auto-Sleepers Group Ltd. Other providers may offer similar products that may or may not meet your needs.

Which services will we provide you with?

We will advise and make a recommendation for you after we have assessed your insurance needs for **Guaranteed Asset Protection (GAP).**

We will review suitable finance products for you after we have assessed your needs for; Hire Purchase or Personal Contract Purchase (PCP).

You will not receive advice or recommendations from us for motorhome insurance.

You are not obliged to agree with our recommendations or to make use of any purchase of a financial product. You may obtain free, independent financial and insurance advice from the Money Advice Service at www.moneyadviceservice.org.uk.

What will you have to pay us for this Service?

We will arrange the policy with the insurer on your behalf. You do not need to pay us a fee for doing this. We will receive a revenue from the sale of the product, which is based on the margin between the selling price, nett of insurance premium tax, and the cost price to us.

You will receive a quotation which will tell you about any other fees relating to any particular insurance policy.

You will make no payment to us for introduction to finance providers, but we will receive a payment(s) or other benefit from the finance provider if you decide to enter into an agreement with them. You may ask us for details of such payments.

Who regulates us?

The FCA is an independent watchdog introduced to regulate Financial Institutions and its services. It requires us to give you this document. You should use this document to decide if the information provided means that our services and products are suitable for you. What to do if you have a complaint.

Are we covered by Financial Services Compensation Scheme (FSCS)?

We are covered by the FSCS. You may be entitled to compensation from the scheme if we cannot meet our obligations. This depends on the type of business and circumstances of the claim. Insurance advising and arranging is covered for 90% of the claim, without any upper limit for compulsory classes of insurance. Insurance advising and arranging is covered for 100% of the claim, without any upper limit.
